The 2009 Tucson Celtic Festival & Scottish Highland Games will be held on Saturday, November 7 & Sunday, November 8 at Rillito Raceway Park, 4502 North 1<sup>st</sup> Avenue, Tucson, AZ. The site will be available for set-up from 10:00am-5:00pm on Friday, November 6. The Friday Evening Feast of Tara is a Special Dinner & Entertainment Evening and Food Vendors are not permitted to be open for business on Friday.

**Festival Hours of Operation: Saturday:** 9:00am–10:00pm **Sunday:** 9:00am–5:00pm

Please be aware that the East Field Overhead Bright Lights will be turned off on Saturday Evening from 7:00-7:30pm for the Fire Dance Performance and will come back on immediately at 7:30pm for the Concert by Brother!

**NOTE: Vendors will please remain open on Sunday until 5:00 pm.**

The Feast of Tara Evening which includes Dinner at 6:00pm, Torchlight Ceremony of Honor at 7:30pm and Ceilidh at 8:00pm will be held at the Festival site on Friday, November 6. Ticket info is on the application.

**Deadline for submission of the Food Vendor Application is October 1, 2009.**

Please note that **there are changes** in the Pima County permitting process! A Pima County Temporary Food Permit is required. **The application must be received by the Pima County Health Department 14 days prior to the Festival.** If it is not received within this timeline, you will be charged a late fee. Complete instructions, rules, and fees schedule for a Temporary Food Permit are enclosed. **You must display your permit at the Festival.**

Your submission of an application to be a food vendor does not necessarily guarantee you a spot. If you are accepted to participate in this year's Festival, you will receive an acceptance letter. If you are not accepted due to lack of space, you will be notified and your space fee will be refunded. If you have any questions please email or call me. Note: If you are accepted to participate as a food vendor and cancel after September 30<sup>th</sup>, your fess will not be refunded.
